Guidelines and Conditions

By submitting your film, you agree to the Festival's submission guidelines and its conditions.

I. About the festival

The Ji.hlava International Documentary Film Festival is a significant European festival featuring artistic and critically reflective documentary work. The 28th annual Ji.hlava IDFF will take place from October 25th to November 3rd, 2024 in person in Jihlava and the subsequent two weeks in an online setting.

2. Film submissions

We accept submissions of the following:

- Documentary films
- Experimental films
- Animated films or hybrid projects
- Various TV and film formats based on real life
- Virtual reality (VR) projects
- Documentary and educational computer games
- Interactive web documentary projects

For every film you submit, you must comply with the following conditions:

- All film submissions must be accompanied by a properly completed submission form, and any changes made to the data provided on this form must be updated in a timely fashion.
- The cost for submitting a film is a one-time €25 administrative fee.
- You should provide an **online** preview of the film you are submitting. Failure to do so will result in your film submission being rendered **invalid**.

Deadlines for submitting your films are broken down as follows:

Despite these deadlines, we kindly ask that you start submitting your films beginning on January 15, 2024, in order to allow ample time for us to review them.

- Submit by February 29th, 2024 (for films completed in 2023)
- Submit by April 30th, 2024 (for films completed in 2024 and premiered before April 30th, 2024)
- Submit by June 30th, 2024 (for rough cuts and films that have not yet had a festival world premiere)

As of June 30, 2024, the possibility to officially submit and register a film in the Ji.hlava IDFF system will end. However, in case of rough cuts, the finished film can be sent to JIDFF until **15 August 2024.**

2.1. Submission fees

Film submissions are subject to an administration fee in the amount of $\in 25$ per film. All films must be submitted separately, with relevant contact information for the purpose of further communication. A submission is not considered valid until payment of the submission fee has been remitted. Submission fees are further used to financially reward the winning films.

Ji.hlava IDFF does not bear any responsibility for repeated submissions of the same film, be it intentional or accidental, nor does it bear any responsibility for the failure to deliver a film by the proper deadline. **All paid submission fees are final, and no refunds will be issued.**

2.2 Acceptable submission formats

ONLINE PREVIEW

- If a preview of your film is available online, please provide the URL and the password to access your film in the submission form.
- Please note that film previews from online storage or hosting services (downloadable links) will not be accepted.
- Films submitted for preview that are not in English, Czech or Slovak must include English subtitles.
- The online preview **must be made available without restrictions until November 3rd, 2024**. If you change the link or password, you must inform us immediately at submissions@ji-hlava.cz or you will risk your film not being considered for this year's festival.

Failure to provide us with a functional online preview of your film may result in your film not being considered for selection. Ji.hlava IDFF shall not be held liable in the event a preview is not delivered and your submission fee will not be refunded for failure to do so.

3. Ji.hlava IDFF programme selection process

3.1. Films selected for the programme

- Films are selected for the programme by the Programme Board in collaboration with curators of individual thematic sections and external programmers.
- The festival and the Programme Board reserve the right to choose what section the film will be included under.
- The festival reserves the right to include in the programme an additional screening of award-winning or acclaimed films.
- If a film has been selected for the festival programme, the Submitter will be notified by **September 20th, 2024** at the latest.
- If a film has not been selected for the festival programme, the Submitter will be notified by **September 20th, 2024** at the latest.

- Ji.hlava IDFF is not obliged to justify its decision or provide feedback on films that have been submitted.
- Ji.hlava IDFF reserves the right to include a repeated or added screening of the award-winning films.

3.2. Programme sections - competition

Opus Bonum – an international competition section for medium-length and feature-length documentary films from all around the world. Under this section, the award for Best Debut and Best Film from Central and Eastern Europe will be announced. The jury may also award films for Best Edit, Best Cinematography, Best Sound Design, and Original Approach.

Czech Joy – a competition for the best documentary film from a Czech production or co-production. The jury may also award films for Best Edit, Best Cinematography, Best Sound Design, and Original Approach.

Testimonies – on politics, nature and knowledge – an international competition for the best documentary film featuring political and historical implications, ecology, and environmental issues, or the best documentary film that pushes the boundaries of the scientific documentary drama.

Fascinations – an international competition for the best experimental film under 30 minutes long **Fascinations – Exprmntl.cz** – a competition for the best experimental film from a Czech production or co-production under 30 minutes long

Short Joy – an international competition for documentary films under 30 minutes. (As a condition, films from this section will be presented online on the international platform <u>dafilms.com</u>. The competition starts 14 days before the festival and is held by a worldwide audience vote on <u>dafilms.com</u>. The award for the best film in the section is presented at the opening ceremony of Ji.hlava IDFF. All films in the section are also screened physically in the festival cinemas.) **First Lights** – competition of student films

Virtual Reality – international competition of 360° films, immersive installations and interactive projects that explore real life, history or social situations.

3.3 Categorisation based on running time

Submitted films are categorised as follows:

- Short-length films with a runtime of under 30 minutes
- Medium-length films with a runtime of between 30 and 60 minutes
- Feature-length films with a runtime of over 60 minutes

3.4. Festival premiere status

A world, international, or European premiere is an essential prerequisite for screening films under the following competition sections:

- Opus Bonum
- Fascinations
- Short Joy
- First Lights

The Submitter is required to provide up-to-date and accurate information about the premiere status of the film that they've submitted. Please notify us at <u>submissions@ji-hlava.cz</u> if the premiere status of your film changes following its submission. In exceptional cases, Ji.hlava IDFF reserves the right to present the film without a premiere in the festival's non-competition sections.

3.5. Confirming festival participation

After the Submitter has been officially notified that their film has been selected for the programme and after the Submitter agrees to show their film, the Submitter is thereby obliged to participate in the festival. After this mutual agreement is made, it is no longer possible for the Submitter to withdraw their film(s) from the programme.

3.6. Festival screening times

Ji.hlava IDFF reserves the right to decide on the screening times and number of screenings of each film title.

4. Additional materials for films selected for the programme

4.1. Screening copy

Ji.hlava IDFF enables screenings in the following formats: DCP, 35 mm, 16 mm, and 8 mm.

4.1.1. Hardcoded subtitles

All films whose primary language is not English must have hardcoded English subtitles. This includes films in Czech, which must also have English subtitles.

4.1.2. Shipping requirements

- The screening copy of a film must be delivered to the Ji.hlava IDFF office in Prague, or delivered electronically (see shipping instructions), no later than September 15th, 2024, unless agreed otherwise. If the copy is not delivered in time, Ji.hlava IDFF will not be responsible for the technical quality of the screening.
- Ji.hlava IDFF shall only cover the cost of a one-way shipment of the film copy unless agreed otherwise.
- The Festival assumes the responsibility to arrange insurance for the copy from its arrival at the office to its subsequent dispatch at the end of the festival.

- Accompanying promotional leaflets, posters, etc. are welcome only in digital format. If you plan on attending the festival in person, bring the promotional materials with you. We will inform you on the spot where to place the materials.
- All screening copies will be sent back to their rightful owners (or to another party as agreed with them) no later than December 1st, 2024.
- In the event a copy is damaged, please inform the Festival no later than December 31st, 2024.
- When shipping copies from countries outside the EU, please provide a pro-forma invoice and do not estimate the value to be over \$10. Please attach the following specification to the parcel: "*No commercial value, for cultural purposes only.*"

4.2. Accompanying film materials

Films selected for the programme must be accompanied by materials as specified by the Festival and are to be made available for use both during and after the festival.

Film clip

For purposes of promoting the film in the media as well as during the festival, please provide a one-minute clip from the film in HD quality. In the event that we have no film clip on file, we reserve the right to select a sequence of our choice.

Trailer

For further promotion of the film at the festival and on the festival's social media, such as the Ji.hlava IDFF YouTube channel, we ask that you provide us with the film's official trailer. The trailer must contain information of the film's inclusion in the festival as well as the official Ji.hlava IDFF selection logo. The logo (laurels) is available for download <u>here</u>.

Film preview

By completing a submission form, the Submitter agrees that his/her films selected for the festival programme will be included in the festival's video library and the library of the Centre for Documentary Film.

For the purposes mentioned above, all video files must be sent with the following specifications:

- File type: .mp4, codec h.264
- Resolution: at least 720p (1280x720px)
- Data speed: between 1.5 and 3 Mb/s
- Audio parameters: AAC, 48KHz, stereo, 160kbps

Online film preview

Filmmakers are required to provide an online preview of the selected film. Ji.hlava IDFF has the right to privately share this preview with select journalists, film synopsis and content writers, and/or translators before the festival and while the festival is taking place.

Dialogue list

All films selected for the festival programme must be accompanied by a dialogue sheet (in the film's

original language or English) to translate and add subtitles to the film or for simultaneous interpretation during a film's screening.

Stills and official poster

For every film that is selected, you must provide the festival with at least three stills no larger than 10 MB each and in .jpg or .png format (.tiff and other formats will NOT be accepted). In the event of failure to provide the necessary photographs, the festival reserves the right to use screen grabs from the film preview. The inclusion of a film poster in digital format is optional. The festival bears no responsibility for the distribution of physical posters.

4.3.1 Use of accompanying materials

By sending additional materials, the Submitter grants their consent for Ji.hlava IDFF to use them for non-commercial purposes and to provide them to third parties for the same purpose. Ji.hlava IDFF is not responsible for securing the license to use the materials you provide, nor does it bear any responsibility in the event of copyright infringement. Additionally, the Submitter declares that they have properly resolved all copyright issues related to the film and all its accompanying materials.

4.3.2 Catalogue and film information

If a submitted film is selected for the festival programme, the Submitter is required to provide truthful and current information on the film as well as contact information for the Rightsholder of the film. This information will be published on the festival website on the film's landing page.

Ji.hlava IDFF reserves the right to use its own film synopsis and film annotation. The annotation provided to the Festival by the Submitter is for referential purposes only.

5. Online film screenings

A portion of the film programme will also be made available online in the two weeks subsequent to the in-person festival in Jihlava. Films selected for the online festival will only be screened upon bilateral agreement with the Rightsholder under pre-arranged terms and conditions. Films selected for the online segment of the festival will be available for viewing only within the territory of the Czech Republic and for the agreed-upon time limit, or with a limit on the number of views (unless otherwise agreed).

6. Festival video library, the Centre for Documentary Film video library

6. I. Festival industry video library

Ji.hlava IDFF reserves the right to use films that are included in the festival programme for its online festival industry video library, which is intended for film professionals attending the festival. This library will continue to be made available for up to three weeks.
